These are some of our specialized psycho-educational and treatment programs:

Substance Related Programs

- ASAM Level 0.5
12 week psycho-educational program
- ASAM Level I - Short-Term
6-12 weeks early intervention
- ASAM Level I - Long-Term
17-52 weeks outpatient treatment
- Relapse Prevention
12 week post-graduation program

Family Violence Intervention Program

- 24-Week Psycho-educational Program based on the guidelines set by the Georgia Commission on Family Violence (GCFV) O.C.G.A §19-13-10.

Anger Management Program

- 12-Week Cognitive Behavioral Program based on the guidelines set by the US Department of Health and Human Services

Parenting Skills Program

- 6 to 12 Week Psycho-educational Program based on the Partners on Parenting Program in conjunction with culturally sensitive best practices programs.

Victim Impact panel

- 2 Hour Educational Program offered once a month. Sessions are educational, engaging and designed by experts to help reduce drunk driving incidents.

Values Clarification Program

- 4-Week (8 hrs total) based on the Gwinnett County Solicitor's Office Program Standards
- Other Counties adhere to the Best Practices Models accepted by DHS

Shoplifters Alternative Program

- 1-Day (8 hrs total) this program is designed to meet the needs of the DeKalb County Court System, usually offered on weekends.

Theft Awareness & Prevention Program

- 3-Hour Class based on the standards set by the National Safety Council. This program is designed to meet the needs of the Cobb County Court System.

Risk Reduction Program – DUI School

- 20-Hour Prevention Program based on the PRIME FOR LIFE curriculum; which is an evidence-based program designed to gently but powerfully challenge common beliefs and attitudes that directly contribute to "high risk" alcohol and drug use.

Defensive Driving Classes

- 6-Hour Education Program; The National safety Council offers a comprehensive driver improvement program designed to give drivers practical knowledge and techniques on how to avoid collisions and violations, and to choose safe, responsible, and lawful driving behaviors.

Drug Testing

- Alcohol and Drug Testing On-Site: Hair, Saliva, Breath, Urine. Laboratory confirmation.
